Review Your Tax Withholdings

As you may recall, when you retired, you were given the chance to choose whether you want federal or state of Wisconsin income tax withheld from your benefit payments. You may change your withholding choices any time you wish. Your current withholding choices will remain in effect until you file new election forms with the Fund Office. **If you do not wish to make a change at this time, nothing further is needed from you.**

Withholding is one way for you to pay a portion of your income tax. If no tax or not enough tax is withheld from your benefits, you may have to pay estimated taxes during the year or a tax penalty at the end of the year. Of course, whether you have to pay income tax on your benefit payment depends on the total amount of your taxable income. Your decision on withholding is an important one. You may wish to discuss it with a qualified tax advisor.

Our Pension Plan is Getting a Makeover

Starting on June 1, 2024, the pension plan design will change to a Variable Annuity Pension Plan (VAPP). Here's what that means:

- The changes apply only for benefits accrued on and after June 1, 2024. Benefits you've already accrued, including those paid to current retirees, will not be affected.
- · Your benefit amount will change based on how the Fund's investments do in the market.
- · Your benefit will be better protected from inflation.
- The Fund will have more security to pay benefits for years to come.

This is a new approach, and the Trustees want you to understand how it works. Active members should expect an educational guide in the mail detailing the changes. Additionally, an informational video explaining the VAPP will be available on the Fund's website at: www.thepensionfund.com.

Notify the Fund Office with Changes

If you are moving (or have moved), or if your phone number has changed, please take a moment to call the Fund Office at **262-784-7880** and update your information. We want to keep you informed about your pension benefits and we send you several mailings throughout the year required by federal law. The U.S. Postal Service may advise us you have moved and your mail may be returned to us. If your mail is returned to us and our attempts to locate you fail, we are unable to issue benefit payments until you contact us with your new address.
