Monthly Pension Benefit Payment Schedule for Direct Deposit

Monthly benefits are paid on the first business day of each month. Saturdays, Sundays, and Federal holidays are not considered business days. For example, December 1, 2024, is a Sunday; therefore, December 2024 benefit payments will be deposited directly into bank accounts on Monday, December 2, 2024. We realize how important timely receipt of your monthly benefit is, and you can be assured that we follow this process every month.

<u>*NOW*</u> is the time to make a change to Direct Deposit

If you have your pension check mailed to you, we encourage you to make the change to direct deposit. Your monthly benefit will be in your bank account on the first business day of each month. Those who continue to have their check mailed should be aware that checks will be mailed from the Fund Office two days before the first of the month. The Fund Office receives many calls from pensioners who do not receive their check on time. By using direct deposit, you can be assured that your pension check will be in your account by the first business day of each month. If you wish to utilize this service, simply contact the Fund Office for a Direct Deposit Form.
